Polasaí um Chúram Leithris & Riachtanais Cúram Pearsanta

Leanaí a bhfuil meastóireacht shonrach acu um riachtanais leithris/cúram pearsanta measúnaithe:

- I ngach cás ina ndearnadh measúnú ar dhalta le riachtanas leithris/cúram pearsanta, tionólfar cruinniú, a luaithe is féidir tar éis an diagnóise.
- Freastalóidh tuismitheoirí, caomhnóirí, príomhoide, múinteoir ranga, CRS, gairmithe ábhartha lasmuigh agus más cuí, an dalta.
- Déanfar soiléiriú ar riachtanais chúraim shonracha páiste agus ar an gcaoi a gcomhlíonfaidh an scoil iad.
- Aithneofar pearsanra a bhfuil baint acu leis an gcúram seo.
- Tabharfar breac-chuntas ar an soláthar le haghaidh ócáidí nuair a bhíonn ball foirne as láthair. Pléifear aon athrú pearsanra leis an dalta, más cuí.
- Déanfar aon athruithe a phlé le tuismitheoir/caomhnóir agus dalta más gá.
- Iarrfar ar thuismitheoirí na hítimí riachtanacha go léir a bhaineann le riachtanais leithris agus cúram pearsanta a bpáiste a sholáthar, de réir phlean cúraim an dalta.
- Chomh fada agus is féidir, beidh an dalta páirteach i sainaitheint a riachtanais phearsanta, mianta, athruithe srl.
- Iarrfar ar thuismitheoirí an fhoirm cheaduithe leithris agus cúraim phearsanta a shíniú agus coinneofar cóip de chead na dtuismitheoirí ar phlean cúraim an dalta.
- Cuirfear in iúl do thuismitheoirí faoi aon athruithe ó nósanna imeachta comhaontaithe.
- Beidh dínit agus príobháideacht an dalta i gcónaí fíorthábhachtach chun aghaidh a thabhairt ar riachtanais chúraim phearsanta.
- Caithfidh an fhoireann lámhainní cosanta.

Leibhéil foirne:

Déanfar breithniú cúramach ar chásanna aonair le fháil amach cé mhéad duine fásta go mba chóir a bheith i láthair le linn nósanna imeachta cúraim phearsanta. Nuair is féidir, tabharfaidh duine fásta amháin aire do dhalta amháin. Má tá duine eile ag teastáil ó dhuine fásta, féadfar iarraidh ar SNA, múinteoir nó príomhoide cúnaimh a sholáthar.

Timpistí leithris:

- I gcás timpiste leithris, rachfar i dteagmháil le tuismitheoirí nuair is gá agus iarrfar orthu athrú éadaí a thabhairt isteach dá bpáiste, mura bhfuil sé seo curtha ar fáil cheana féin.
- Sa chás gur dócha go dtarlóidh timpistí, iarrfar ar thuismitheoirí athruithe laethúla éadaí a sholáthar.
- Cuirfear in iúl do thuismitheoirí faoi timpiste leithris ar bith a tharlaíonn le linn an lae scoile.

- Beidh meas ar dhínit agus ar phríobháideacht an pháiste i gcónaí. Spreagfar cur chun cinn féinchúraim.

Leithreas agus an Clós Súgartha:

- Ba chóir do mhúinteoirí agus do CRSanna páistí a spreagadh chun an leithreas a úsáid sula bhfágann siad an seomra ranga le haghaidh sosanna lasmuigh. Dá bhrí sin, ba chóir go mbeadh páistí a dteastaíonn uathu teacht isteach ón gclós le linn am sosa chun an leithreas a úsáid, mar eisceacht seachas an norm. Sa chás go gcaithfidh páiste an leithreas a úsáid agus iad ar an gclós súgartha, rachaidh ball foirne in éineacht leis an bpáiste go dtí an seomra ranga. Cinnteoidh an ball foirne go bhfillfidh an páiste go sábháilte ar an gclós súgartha. Má theastaíonn cúnamh ó pháiste sa leithreas, glaofaidh an ball foirne ar chomhghleacaí sula gcuirfidh sé/sí cúnamh ar fáil. Beidh meas ar dhínit agus ar phríobháideacht an pháiste i gcónaí.


Iompar Dúshlánach:

Cosaint Leanáí:

Cloífear le nósanna imeachta cosanta leanáí i gcónaí, de réir ráiteas cosanta linbh na scoile. Rinneadh grinnfhiosrú ar gach ball den fhoireann. Má dhéanann páiste líomhain faoi bhall foirne, déanfar é seo a fhiosrú de réir nósanna imeachta comhaontaithe.



Toileting & Intimate Care Needs Policy

Children with Specific Assessed Toileting/Intimate Care Needs:

- In all situations where a pupil has been assessed with Toileting/intimate care need, a meeting will be convened, as soon as possible after diagnosis.
- Parents, Guardians, Principal, Class Teacher, SNA, relevant outside professionals and if appropriate, the pupil, will attend.
- The specific care needs of the child, and how the school will meet them, will be clarified.
- Personnel involved in this care will be identified.
- Provision for occasions when staff are absent will be outlined. Any change of personnel will be discussed with the pupil, if appropriate.
- Any changes will be discussed with parent/guardian and pupil if necessary.
- Parents will be requested to provide all necessary items associated with their child's toileting and intimate care needs, as per the child's care plan.
- As far as possible the pupil will be involved in identification of his/her personal requirements, wishes, changes etc.
- Parents will be asked to sign the Toileting and Intimate Care Permission form and a copy of the parental permission will be kept on the pupil's Care Plan.
- Parents will be notified of any changes from agreed procedures.
- At all times the dignity and privacy of the pupil will be paramount in addressing intimate care needs.
- Staff will wear protective gloves.

Staffing Levels:

- Careful consideration will be given to individual situations to determine how many adults should be present during intimate care procedures. Where possible, one pupil will be cared for by one adult. If another adult is required an SNA, teacher or principal may be called upon to provide assistance.

Toileting Accidents:

- In the case of a toileting accident, parents will be contacted when necessary and requested to bring in a change of clothing for their child, if this has not already been supplied.
- Where accidents are likely to occur, parents will be requested to provide daily changes of clothes.
- Parents will be notified of any toileting accident which occurs during the school day.
- The dignity and privacy of the child will be respected at all times. The promotion of self-care will be encouraged.

Toileting and the Playground:

- Teachers and SNAs should encourage children to use the toilet before leaving the classroom for outdoor breaks. Children needing to come in from the yard during break time to use the toilet should, therefore, be the exception rather than the norm. In the event that a child needs to use the toilet while on playground, a member of staff will accompany the child to the classroom. The staff member will ensure that the child returns safely to the playground. Should a child require assistance in the toilet, the staff member will call on a colleague before providing assistance. The dignity and privacy of the child will be respected at all times.


Challenging Behaviour:

- In the case of challenging behaviour where a child refuses toileting, dressing or intimate care assistance, parents will be contacted immediately and will be requested to come to the school in the best interest of the child's dignity, health and safety.

Child Protection:

- Child Protection procedures will be adhered to at all times, in accordance with the School's Child Safeguarding Statement. All members of staff carrying out intimate care needs have been Garda vetted. If a child makes an allegation about a member of staff, this will be investigated in accordance with agreed procedures.
